Chief Delfs addressed the Board, stating that documents were handed out in the packet. He asked that all packets be turned in at the conclusion of the meeting because of the confidential information contained therein. The Chief explained that the PSPRS statute states that in order for a claim to be accepted, an independent medical examiner must conclude that an injury totally prevents an employee from performing a reasonable range of duties within their job classification, the injury is permanent, and that the injury must have been incurred in the line of duty. The documentation from Dr. Nelson unequivocally states that Mr. Fiori's injury is not total, nor is it permanent. Counsel Bosse informed the Board that their course of action could be to either table the application to request more information or deny the application. After no further discussion, Captain Donaldson motioned to deny Mr. Fiori's application for accidental disability. Chief Kennedy seconded. *Motioned carried unanimously*, 5:0.
