10. FUND INFORMATION

Chief Delfs addressed the Board to highlight the following items regarding the PSPRS Pension Funds:

- Pending the Supreme Court decision, the employee contribution rate may be increased for the next fiscal year. It has been speculated that the employee rate may be rolled back and that the employees may be refunded their contributions back to the enactment date of SB1609. That decision may be made soon.
- The assumed earnings rate for the fund has been lowered from 7.85% to 7.5% on investment earnings over the next 30 years. In order to make up any shortfall on investment earnings, the employer contribution rate will see a corresponding increase of 3% for every 1% that the rate is lowered. This may have a significant impact on the District's employee related expenditures.
- Per a recent IRS audit, the PSPRS discount rate was lowered. As a result, the cost of buying time will become more expensive to the employee.

11. ADJOURNMENT

Chairman Neilson motioned to adjourn the meeting. Captain Kennedy seconded. Motion was unanimous, 5:0. Meeting adjourned at 9:16 AM.
