7) Announcements, Current Events & Correspondence

The Board packets included information regarding proposed legislation affecting Fire Districts. Also included in the Board packets was information regarding the loss of firefighter, Lt. Bobby Mollere, from Hellsgate Fire Department.

8) Chief's Reports

- Chief Delfs training, vehicles, labor relations, personnel, stations, communications
- Chief Klein operations and response times

Assistant Chief Klein addressed the Board, commenting that the District is continuing to exceed operational response times. Also, WW Williams has scheduled Engine 217 for display at a fire equipment conference later this month. The engine will be placed into service shortly thereafter. Lorrie will followup with information on admission tickets.

9) <u>Review, Discussion and possible Action</u> to approve the February 2014 Financial Reports and authorize the Chairman and Clerk to sign the *Certificate of Review*.

Lorrie provided a brief summary of the financial information provided in the Board packets, commenting that the statements and related information are always available for review. Vice-Chairman Lassen motioned to approve the February 2014 Financial Reports and authorize the Chairman and Clerk to sign the *Certificate of Review*. Director Neilson seconded. *Motion carried unanimously*, 4:0.

10) Reports of Board Members and Staff

Chairman Castaneda reported that he and Chief Delfs represented our District at the Pinal County Special Districts meeting held March 18, 2014 in Casa Grande.

11) Review, Discussion and possible Action regarding the building projects

Assistant Chief Klein addressed the Board, stating that Chief Delfs is still in a meeting with Pulte and Pinal County. He will send an email later today communicating the results of the meeting and updating the Board members on the progress of the building projects.

12) <u>Review, Discussion and possible Action</u> regarding the IGA between Avra Valley Fire District and Golder Ranch Fire District for outsourced Medical Billings

Assistant Chief Klein directed the Board to the Golder Ranch IGA addendum which was provided in their packets. Golder Ranch has approached the District about a three-year agreement, ending March 2017. Chief Delfs negotiated to keep the outside billing rate at 4% for another year, then move to 5% the next year, and 6% in year three. Most other Districts they provide service for are billed at 6%. Avra turned over a license agreement to them so they reduced our rate to compensate. Vice-Chairman Lassen commented that we were paying at 7% with the prior outside biller. She further commented that for accounts turned to collections, the District contracted with PCS Collection Agency last August because of their lower fee and better collection capability. Counsel Wencker confirmed the collection service fee at 21%.

Vice-Chairman Lassen motioned to approve the addendum to the IGA between Avra Valley Fire District and Golder Ranch Fire District for outsourced Medical Billings. Director Neilson seconded. *Motion carried unanimously*, 4:0.

13) Future Agenda Items

Chairman Castaneda expressed concern regarding the proposed legislation relating to Fire Boards. He asked Counsel Wencker to research the issues and provide direction to the Board as soon as possible.
