The Chief highlighted the following items from his report:

We ended the fiscal year less than half a percent off budget and have a five year sustainable budget plan in place in spite of falling property tax revenues. We have strong financial controls in place and continue to receive a clean audit annually.

We responded to 15 wildland incidents.

We received grant monies which enabled the District to replace an ambulance, heart monitors, radios, wildland equipment and rescue equipment.

We remain one of the few fire districts with the lowest pension debt in the State.

We exceeded self imposed and DHS imposed CON response times every month, even though the District implemented stringent COVID protocols.

The District modified and adopted the 2018 International Fire Code

The District had 7 employees term during the fiscal year. We implemented a compensation step increase of 2.5% for all employees as of July 1, 2020. Although we did change carriers for both our workers comp and medical benefits, the employee contributions remain cost neutral for them. We have recently hired 4 employees plus an eligibility list has been established.

Vice-Chairman Bauer motioned to approve the June 2020 financial reports and authorize the Chairman and Clerk to sign the *Certificate of Review*. Director Neilson seconded. *Motion carried unanimously*, *4:0*.

10. <u>EXECUTIVE SESSION</u> REGARDING THE ANNUAL EVALUATION OF THE FIRE CHIEF'S PERFORMANCE AND EMPLOYMENT

Pursuant to A.R.S. section 38-431.03(A)(1), the Governing Board may vote to enter Executive Session for discussion and consideration of employment, assignment, appointment, promotion, demotion, salary, benefits, discipline, or dismissal of Fire Chief Brian Delfs. Chief Delfs has been notified as required by law and he has waived his right to request that deliberations be held during a meeting open to the public.

Chief Delfs confirmed that he was notified in advance. Chairman Castaneda motioned to move into Executive Session to include all Board members, the Chief and Counsel Wencker. Seconded by Vice-Chairman Bauer. *Motion carried unanimously*, *4:0* Time: 8:23 AM
