9. CHIEF'S REPORT

The Fire Chief may update the Board on items of interest relating to but not limited to the following: fire suppression, EMS and wildland services, response times, vehicles, facilities, labor relations, personnel, finance, grants, communications and/or training. The Chief highlighted the following items from his report:

Avra Valley Fire District has been selected as a tester for the Medicare Ground Ambulance Data Collection Project (GADS) which will begin for many ambulance transport entities in January 2022. The testing will enable the project administrators to analyze the appropriateness of their online portal in capturing the copious amount of data required from selected ambulance entities. The final goal of the project is to submit communication to Congress regarding the appropriateness of Medicare disbursements to citizens, as well as to assist in determining appropriate billing rates. Most ground ambulance entities will be required to report at some point within the data collection period. Those who do not will be penalized with a 10% reduction in their Medicare billing revenue.

Director Bauer inquired about the current hiring process. Chief Delfs responded that the District is currently in a joint hiring process with Three Points Fire District to fill two positions. The Reserve Program will only be for firefighters between Three Points Fire District and Avra Valley Fire District. We are not hiring Reserves from the outside. A brief discussion ensued.
