7. ACCEPTANCE OF THE EMPLOYER RATE OF 18.93% AND THE FY2021 EMPLOYER MATCH FOR THE 401(A) DEFINED CONTRIBUTION WHIH HAS BEEN AVERAGING \$1300 PER PAY PERIOD

The employer contributions are adjusted annually. There is no cap on the increase. Disability retirements impact this rate the most.
