- The air conditioning unit at Station 194 has been scheduled for replacement as soon as next week
- The management arrangement with Three Points Fire District is going well. There is a lot of work to do. During the first six weeks, we are putting together a planning matrix. Once it is complete, we will have solid starting points. Our firefighters responded in the Three Points area 112 times last year, so the staff is already quite familiar with each other.
- We are pleased to have hired a part time mechanic who will be assisting Tom no more than 10 hours per week. Mr. Bailey retired from Northwest Fire District. He will operate the service truck between stations to help with preventative maintenance, and other duties as needed.
- We had one firefighter who did not successfully complete probation, so we will be hiring another individual in the near future.
