8. CHIEF'S REPORT

The Fire Chief may update the Board on items of interest relating to but not limited to the following: fire suppression, EMS and wildland services, response times, vehicles, facilities, labor relations, personnel, finance, grants, communications and/or training. The Chief highlighted the following items from his report:

- The new hires are very qualified candidates.
- SAFER Grant application is still outstanding. If it is successful, we will enter another hiring process.
- The new ambulance has been delivered and is currently being outfitted. We anticipate it will be placed in service within a couple of weeks.
- Mrs. Palmquist has built the depreciation module which was required by the auditors. The annual audit will be conducted remotely this year, and significant progress is being made to deliver all required documentation.
- As we are seeing a significant rise in home sales, the possibility of a drop in property tax collections may not occur as anticipated.

Chief Klein is working on a comprehensive update of both our phone and computer systems. We have verified that all personnel are aware of what overtime compensation is available to them
