6. ANNOUNCEMENTS, CURRENT EVENTS & CORRESPONDENCE

AFDA notified us today that the January 2022 Conference will be held January 20-21 at Casino Del Sol in Tucson. Mandatory training classes for Board members will also be held in several cities throughout the State, as well as being available for independent study at a accost of \$150.

The Chief highlighted the following items from his report:

During the fiscal year, we have had several terminations and several new hires. We are currently in a hiring process to bring on 4 additional personnel.

Our wildland invoices have been paid in a timely fashion, with only 2 invoices still outstanding. The State is looking at implementing a new wildland billing rate system.

Avra Valley Fire has been fortunate to have so many spots for technical rescue training classes. In fact, historically we have sent more personnel per capita than any other District in the State.

A brief preview of the Preliminary FY22 Budget which will be presented at the next meeting:

Audit cost will go up significantly due to the required Federal A133 audit and the recent legislation which will probably require a full CAFR.

CIGNA rates will go up next fiscal year, with an *average* increase reported at 12% Newly hired employees will require turnouts, extra training, physicals, etc.

Per the recent Pima Fire Chief's wage study, we hope to give a 2.5% increase on July 1

We will begin to see a small recovery in our tax levies due to increased assessed values.

Also, current legislation may allow us to maintain our \$3.50 tax rate permanently.

We will not be receiving an increase for our ambulance billing rate.

Evolve Tactical closed their doors last week. We have a proposal from Sunbelt Medical, and we have spoken with another vendor for which we have no proposal yet.

9. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO APPROVE THE FEBRUARY 2021 FINANCIAL REPORTS AND AUTHORIZE THE CHAIRMAN AND CLERK TO SIGN THE CERTIFICATE OF REVIEW

Vice-Chairman Bauer motioned to approve the February 2021 financial reports and authorize the Chairman and clerk to sign the *Certificate of Review*. Director Armendarez seconded. *Motion carried unanimously*, 5:0.

10. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO APPROVE POLICY 4-09: WORKER'S COMPENSATION

Chief Delfs addressed the Board discussing the proposed change in policies which would allow a change in the amount of time an employee can be off work. Chief Delfs stated that when an employee must be off work or on light duty, the District will begin evaluating the situation on day 1, and after a 6-month period off work, the employee would be terminated. There is a caveat included that if the employee obtains an independent medical exam confirming that the employee will be able to return to work, the policy would allow for the time off to be extended by an additional 6 months. Chief Delfs stated that he consulted several other districts regarding their similar policies. Counsel Wencker addressed the Board describing that in general, FMLA is available by Federal law. However, nothing prevents the District from limiting the amount of time paid to someone who is off duty or on light duty.

After a brief discussion ensued, Clerk Neilson motioned to approve Policy 4-09: Workers Compensation. Vice-Chairman Bauer seconded. *Motion carried unanimously*, *5:0*.

11. <u>REVIEW, DISCUSSION AND POSSIBLE ACTION</u> TO APPROVE POLICY 4-11: FAMILY MEDICAL LEAVE ACT – FMLA

Chief Delfs addressed the Board explaining that in this policy there is an additional caveat stating that benefits will be provided during FMLA leave, but will end when FMLA benefits are exhausted. Vice-Chairman Bauer motioned to approve Policy 4-11: Family Medical Leave Act – FMLA. Clerk Neilson seconded. *Motion carried unanimously*, 5:0.
